The Baker County School Board met on Monday, August 5, 2013, at 5:00 p.m. in the District School Board Room located at 270 South Boulevard East, Macclenny, Florida. The purpose of the meeting was to hold the regular open Board meeting.

Chairperson Griffis announced that Johnnie Jacobs, Director of Transportation, was giving the invocation. He stated that David Davis, Executive Director of Teaching and Learning, would lead the Pledge of Allegiance after the invocation.

**CALL TO ORDER**

Chairperson Griffis called the open Board meeting to order and asked for a roll call of members. The following School Board Members were present to wit: Chairperson Richard “Dean” Griffis, Vice-Chairperson Patricia C. Weeks, Charlie M. Burnett, III (Artie), and Earl “Dwight” Crews. School Board Member Jesse D. Davis was not present at the meeting. Superintendent Raulerson stated that Mr. Jesse Davis asked her to convey to that he would appreciate the Board’s patience with his absence from the meetings until he could resign. Superintendent Sherrie Raulerson and School Board Attorney Jonathan Oliff were both in attendance at the meeting.
