The Baker County School Board met on Monday, August 21, 2017, at 6:30 p.m. in the District School Board Room located at 270 South Boulevard East, Macclenny, Florida. The purpose of this meeting was to hold the regularly scheduled Board meeting. - **Recognition of Jump Rope for Heart Top Fundraising School - Baker County Pre-K / Kindergarten Center** (*Presenter Amy Shirley, American Heart Association Youth Market Director*)

Amy Shirley with the American Heart Association presented a plaque to PKK staff members, Bailey Thomas, Debra Echols, and Principal Bonnie Jones for their help in raising to most funds in the district during the 2016-17 Jump Rope for Heart event. Over \$10,000.00 was raised across the district with the Pre-K/Kindergarten Center raising \$3,757.00 alone.
